3. The proof of purchase (including sales value) of the devices must be uploaded to [www.samsung.com/uk/buyandtry](http://www.samsung.com/uk/buyandtry) website at time of registration and no later.
4. A request to return the product(s) needs to be registered on the website within 28 days of purchase. Only one product per transaction and only the purchased product can be returned. Please ensure that the serial number is registered on [www.samsung.com/uk/buyandtry](http://www.samsung.com/uk/buyandtry) that the proof of purchase is also submitted.
5. A refund will only be made on the registered product(s). No initial delivery costs or other costs incurred will be paid by Samsung Electronics.
